

## HKU SPACE Community College Arrangement for Refund Application 2024-25

It is the policy of the University of Hong Kong that **fees paid are neither refundable nor transferable** except as statutorily provided or under very exceptional circumstances. This document is applicable to students who are enrolled in the College's programmes and satisfy the requirements set out in the "Eligibility" section below<sup>1,2</sup>.

<b>Application Procedures</b>	The Refund Applicant should apply <b>In Person</b> <sup>6</sup> to the Kowloon East Campus (28 Wang Hoi Road, Kowloon Bay, Kowloon) and provide the following documents (signed on each page in copy): <ol style="list-style-type: none"> <li>a. <b>In Original Form and/or in Copy</b> <ol style="list-style-type: none"> <li>i. supporting document(s) to prove the acceptance of an official offer from the eligible programmes (e.g. acceptance information from JUPAS account, offer letter, payment receipt and/or student card of the offering institution which shows the <b>applicant's name, programme title</b> and <b>name of institution</b>);</li> <li>ii. HKU SPACE payment confirmation email / receipt of the registration fee and, if applicable, the first instalment of tuition fee;</li> <li>iii. HKID card; and</li> </ol> </li> <li>b. <b>Copy</b> of a valid bank account document (e.g. first page of the bank passbook/bank statement/ATM card which clearly shows the name of account holder and the account number) [<i>only applicable for tuition fee paid in Cash/EPS/Cashier's Order/Online PPS/Alipay/WeChat Pay/FPS</i>]</li> </ol>	
<b>Fee</b>	5% of the eligible amount will be charged as administrative fee for each successful refund application. The administrative fee will be deducted from the eligible amount and the Refund Applicant will receive a refund net of the administrative fee.	
<b>Refund Payment Methods</b>	If fee payment is made by: <ul style="list-style-type: none"> <li>• <b>Credit Card</b>, refund will be paid to the credit card account</li> <li>• <b>Cash/EPS/Cashier's Order/Online PPS/Alipay/WeChat Pay/FPS</b>, refund will be made via bank transfer<sup>7</sup></li> </ul>	

### Notes:

1. **Refund for non-current HKDSE candidates**  
The application deadline for refund is **five working days** upon receipt of a full-time UGC-funded bachelor's degree offer or 12 September 2024, whichever is earlier. Please note that no refund of registration fee will be made to non-current HKDSE candidates who have not paid the first instalment of tuition fee (i.e. Registration Fee and Balance Payment) by 15 July 2024.
2. The contents of this document do not apply to students who are admitted to a programme cancelled by the College due to insufficient enrolment or other unforeseeable difficulties.
3. Full-time UGC-funded bachelor's degree programmes are provided by the following eight institutions:

Programmes offered by **Hong Kong Metropolitan University** (including those that can be applied through JUPAS) and those offered by **The Hong Kong Academy of Performing Arts** are **not** UGC-funded programmes; applicants accepting an offer from these programmes are thus **not eligible for refund**.

6. The applicant/parent/guardian may authorise a representative who is over the age of 18 to apply for refund with the following documents: i) authorisation letter signed by the applicant; ii) a copy of the applicant's HKID card; iii) the original and copy of the representative's HKID card; iv) documents mentioned in the above application procedures; v) applicant's JUPAS account login information.
7. Third party account will be accepted, but not time deposit, credit card, foreign currency or securities accounts.

行政費	就成功之退款申請，學院將收取該筆合資格退款款項的 5%作為行政費，而此行政費將會從該退款款項扣除。同學實收的退款為扣除行政費後之金額。

- 非應屆中學文憑試考生及持其他學歷考生的學費退款  
申請學費退款時段則另定於考生獲取教資會資助的全日制學士學位課程結果後之五個工作天內或 2024 年 9 月 12 日或之前（以較早者為準）。另外，若非應屆中學文憑試考生及持其他學歷考生於 2024 年 7 月 15 日仍未繳交第一期全額學費（包括註冊費及第一期學費餘額），註冊費的退款申請將不獲本學院受理。
- 此文件並不適用於同學因收生不足而取消開辦課程等特殊情況。

- 可接受第三者戶口，但不接受定期、信用卡、外幣戶口及證券戶口。
